Effects of this medicine
This medicine is a bowel-cleansing agent that eliminates the intestinal contents and cleanses the intestinal tract
by excretion of watery stool.
It is usually used to eliminate the intestinal content as pretreatment for colonoscopy, barium enema contrast X-
ray and large intestine operation.
Before using this medicine, be sure to tell your doctor and pharmacist
•If you have previously experienced any allergic reactions (itch, rash, etc.) to any medicines.
If you have gastrointestinal obstruction, possible intestinal obstruction, intestinal perforation, toxic megacolon,
constipation, abdominal post-operation, angina pectoris, myocardial infarction, renal impairment, or diabetes
mellitus.
•If you are pregnant or breastfeeding.
•If you are taking any other medicinal products. (Some medicines may interact to enhance or diminish medicinal
effects. Beware of over-the-counter medicines and dietary supplements as well as other prescription
medicines.)
Dosing schedule (How to take this medicine)
• Your dosing schedule prescribed by your doctor is((to be written by a healthcare
professional))
•Dissolve the contents of one pouch in water to make about 2 L of a solution. In general, for adults, take 2 to 4
L at a time, at a rate of about 1 L per hour. Discontinue dosing when excretion fluid has become clear. Do
not take more than 4 L of the solution. Strictly follow the instructed method of dissolution and ingestion.
•If you experience abdominal pain, nausea, vomiting, pallor or vertigo while drinking, stop drinking the solution
and immediately consult with your doctor or pharmacist. If you experience these symptoms after you have
finished drinking, also immediately consult with your doctor or pharmacist.
If you have no bowel movement after you have taken about 2 L of the solution, stop drinking the solution and
consult with your doctor.
When taking the solution at home, drink the solution in the presence of an attendant so that the attendant can
take measures when adverse drug reactions occur.
•If you undergo barium enema X-ray, take 20 mg mosapride citrate before and after taking the solution.
• If you miss a dose, consult with your doctor or pharmacist.
• If you accidentally take more than your prescribed dose, consult with your doctor or pharmacist.
•Do not stop taking this medicine unless your doctor instructs you to do so.
Precautions while taking this medicine
Possible adverse reactions to this medicine
The most commonly reported adverse reactions include abdominal bloating, nausea, abdominal pain, feeling cold,
malaise, light-headed feeling, and vomiting. If any of these symptoms occur, consult with your doctor or
pharmacist.
The symptoms described below are rarely seen as initial symptoms of the adverse reactions
indicated in brackets. If any of these symptoms occur, stop taking this medicine and see your
doctor immediately.
•breathing difficulty, facial pallor, semi-consciousness [shock, anaphylaxis]
•abdominal pain, abdominal bloating, vomiting [intestinal perforation, intestinal obstruction, inguinal hernia
incarceration]
•semi-consciousness, convulsion, vomiting [hyponatremia]
•abdominal pain, abdominal bloating, bloody stool [ischemic colitis]
•nausea, vomiting, bloody stool [Mallory-Weiss syndrome]

The above symptoms do not describe all the adverse reactions to this medicine. Consult with your doctor or pharmacist if you notice any symptoms of concern other than those listed above.
Storage conditions and other information
•Keep out of the reach of children. Store away from direct sunlight and heat.
•Take this medicine according to the instructed schedule. The solution that has been prepared in advance
should be stored in a refrigerator and consumed within 48 hours.
•Discard the remainder. Do not store them.
